



# Application for Membership: Student Member

Student membership is available to full time students who are undertaking an approved full-time course in Building Design at a recognised tertiary institution. Proof of enrolment in the Building Design course is required from the tertiary institution. Persons studying part-time are not eligible for Student Membership, but may consider applying for Individual Membership.

Student Members may hold student membership for up to three years, or up to the time they commence employment, whichever comes first.

Benefits of Student Membership include:

- attendance at BDAV CPD evening seminars at no charge, or, where indicated, at significantly reduced rates than those paid by BDAV Members. These events offer excellent networking opportunities with your future employers, and with other students studying building design, which will assist students to establish a peer network;
- ability to place a brief resume in the 'Job Market' section of the BDAV website for those students seeking work experience and part-time job opportunities;

- receiving the BDAV's monthly journal free of charge;
- limited access to specific items contained in the Member Only section of the BDAV website.

One important item able to be accessed by Student Members in the Member Only section of the BDAV website is the BDAV Log Book of Experience, which students find invaluable for recording their practical experience undertaken during their studies. This assists to validate experience and knowledge with prospective employers, clients or government agencies.

It should be noted that Student Members do not have voting rights, and may not use the BDAV logo.

The membership process is quite straightforward: please complete the application form on the accompanying page, and return it to the BDAV, together with the payment, as indicated. Upon acceptance to membership, your membership will be confirmed in writing.
